**CAMED Active Foot Spray** topical spray.

Read this leaflet carefully because it contains important information. **CAMED Active Foot Spray** is available without a doctor's prescription. Nevertheless, you still need to use **CAMED Active Foot Spray** carefully to get the best results.

- Keep this leaflet. You may need to read it again.
- Ask your pharmacist if you need more information or advice.
- You must see a doctor if your symptoms worsen or do not improve.

**WHAT CAMED ACTIVE FOOT SPRAY CONTAINS**

The active substances are:

Each spray (0,15 ml) contains: 0,54 mg Wound Support Proprietary Blend (Organic Acid Complex, Ascorbic Acid). Purified water is present as inactive ingredient.

**CAMED Active Foot Spray** contains no alcohol or preservatives.

**WHAT CAMED ACTIVE FOOT SPRAY IS USED FOR**

**CAMED Active Foot Spray** consists out of a combination of various organic acids and vitamins which supports and improves the wound healing process and contributes to healthy skin.

**BEFORE YOU USE CAMED ACTIVE FOOT SPRAY**

Do not use **CAMED Active Foot Spray**:

- If you are allergic to any of the ingredients (see "**WHAT CAMED ACTIVE FOOT SPRAY CONTAINS**").

Take special care with **CAMED Active Foot Spray**:

- If you suffer from any chronic skin condition (see "**POSSIBLE SIDE EFFECTS**").
- If you suffer from any condition which affects the natural wound healing process, e.g. diabetes (high blood sugar).

Do not apply **CAMED Active Foot Spray** in combination with any other topical medicinal products.

**PREGNANCY AND BREASTFEEDING:**

The safety and efficacy of **CAMED Active Foot Spray** during pregnancy and breastfeeding has not been established.

If you are pregnant or breastfeeding your baby, please consult your doctor, pharmacist or other healthcare professional for advice before using **CAMED Active Foot Spray**.

Using other medicines with **CAMED Active Foot Spray**: Always tell your healthcare professional if you are using any other medicines (This includes complementary or traditional medicines).

**CAMED Active Foot Spray** is indicated for topical use with no systemic absorption of the active ingredients in significant quantities. No interactions are therefore expected.

**HOW TO USE CAMED ACTIVE FOOT SPRAY:**

Always use **CAMED Active Foot Spray** exactly as indicated, or as your doctor or pharmacist has instructed you. You should check with your doctor or pharmacist if you are unsure.

Prepare the affected / itchy area by cleaning it thoroughly with lukewarm water.

Spray **CAMED Active Foot Spray** sufficiently on the affected / itchy area until thoroughly wet. Apply 3 to 5 times per day.

If you use **CAMED Active Foot Spray** more than you should: In the event of excessive use, consult your doctor or pharmacist. If neither is available, contact the nearest hospital or poison control centre.

If you use **CAMED Active Foot Spray** more than what is indicated, it may increase your risk of experiencing side effects (see "**POSSIBLE SIDE EFFECTS**").

**POSSIBLE SIDE EFFECTS**

**CAMED Active Foot Spray** can have side effects. Not all side effects reported for **CAMED Active Foot Spray** are included in this leaflet. Should your general health worsen or if you experience any untoward effects while using **CAMED Active Foot Spray**, please consult your doctor, pharmacist or other healthcare professional for advice.

Inform your doctor of the following side effects if they continue or become bothersome:

- A tingling sensation or irritation at the site of application. If you notice any side effects not mentioned in this leaflet, please inform your doctor or pharmacist.

**STORING AND DISPOSING OF CAMED ACTIVE FOOT SPRAY**

Store at or below 25 °C in a dry place. Protect from light.

Store in original packaging until required for use.

Do not use after the expiry date stated on the label.

Return all unused medicine to your pharmacist. Do not dispose of unused medicine in drains or sewerage systems (e.g. toilets).

**STORE ALL MEDICINES OUT OF REACH OF CHILDREN.**
