#### **SCHEDULING STATUS:**

## PROPRIETARY NAME AND DOSAGE FORM:

CAMED Active Foot Spray topical spray.

#### **COMPOSITION:**

Each spray (0,15 ml) contains: 0,54 mg **CAMED Active Foot Spray** Proprietary Blend (Organic Acid Complex, Ascorbic Acid, Riboflavin). Purified water is present as inactive ingredient.

**CAMED Active Foot Spray** contains no alcohol or preservatives.

#### **CATEGORY AND CLASS:**

D.34.12. Multiple substance formulation.

#### PHARMACOLOGICAL ACTION:

#### Pharmacokinetic properties:

CAMED Active Foot Spray consists of a proprietary blend of various organic acids combined with ascorbic acid (vitamin C). Although pharmacokinetic studies on CAMED Active Foot Spray as a multiple substance formulation have not been conducted, the active ingredients act locally at the site of application and systemic absorption in significant quantities is not expected.

#### Pharmacodynamic properties:

The mechanism of action of **CAMED Active Foot Spray** is twofold. **CAMED Active Foot Spray** firstly has a bactericidal & fungicidal effect, and secondly supports wound healing by providing important vitamins locally at the site of application.

The proprietary blend of various organic acids acts upon the cellular membrane of fungi and bacteria, altering its permeability and the normal functioning of its associated enzymatic pool causing a final cellular membrane rupture. It interacts exclusively with the cellular membrane and not with the DNA which prevents resistance generation and mutation of the microorganisms.

The beneficial effects of ascorbic acid on skin health and wound healing are well-known. Ascorbic acid is an potent antioxidant which contributes to the protection of cells from oxidative stress and is involved in tissue formation. Ascorbic acid contributes to normal collagen formation which supports healthy skin. Ascorbic acid also supports the wound healing process.

## **INDICATIONS:**

**CAMED Active Foot Spray** consists out of a combination of various organic acids and vitamins which supports and improves the wound healing process and contributes to healthy skin.

#### **CONTRAINDICATIONS:**

CAMED Active Foot Spray is contraindicated in:

Patients with a hypersensitivity to any of the ingredients of **CAMED Active Foot Spray** (see "**COMPOSITION**").

## **WARNINGS AND SPECIAL PRECAUTIONS:**

CAMED Active Foot Spray should be used with care in:

Patients suffering from chronic skin conditions.

Patients suffering from any condition which compromises the natural wound healing process, e.g. diabetes.

**CAMED Active Foot Spray** should not be applied concomitantly with any other topical medicinal products.

#### **INTERACTIONS:**

**CAMED Active Foot Spray** is indicated for topical use with no systemic absorption of the active ingredients in significant quantities. No interactions are therefore expected.

#### **HUMAN REPRODUCTION:**

The safety and efficacy of **CAMED Active Foot Spray** in pregnancy and lactation has not been established.

#### **DOSAGE AND DIRECTIONS FOR USE:**

Prepare the affected / itchy area by cleaning it thoroughly with lukewarm water.

Spray **CAMED Active Foot Spray** sufficiently on the affected area until thoroughly wet. Apply 3 to 5 times per day.

#### **SIDE EFFECTS:**

#### Skin and subcutaneous tissue disorders:

Frequency unknown: Tingling or irritation at the site of application.

# KNOWN SYMPTOMS OF OVERUSE AND PARTICULARS OF ITS TREATMENT:

Excessive use of **CAMED Active Foot Spray** may increase the risk of experiencing side effects (see "**SIDE EFFECTS**"). Symptomatic and supportive treatment is suggested in the case of over usage.

#### **IDENTIFICATION:**

A light lemon coloured, viscous liquid with a slight citric odour.

#### PRESENTATION:

A black plastic metered dose spray bottle containing 105 ml **CAMED Active Foot Spray**.

#### **STORAGE INSTRUCTIONS:**

Store at or below 25 °C in a dry place. Protect from light.
